MINUTES OF PARISH COUNCIL MEETING Held at 7.00pm on 19 March 2025 at Astley Village Hall

78.24 Apologies for Absence

Apologies had been received from Councillor K Sumner and Flt Sgt A Foxall.

79.24 Disclosable Pecuniary Interests

- a) Councillor Peate declared an interest in 85.25 but as the application to discharge conditions has been granted since the agenda was issued, this is now a moot point.
- b) There were no applications for a dispensation regarding disclosable pecuniary interests
- **80.24 Public Participation Session** a period of 15 minutes will be set aside for the public to speak, with a strict 5-minute limit per speaker. Members of the public may speak on matters appearing on the agenda. However, if a matter does not appear on the agenda, a written request should be submitted to the Clerk no later than 2 working days before the meeting.

One member of the public spoke of their concerns regarding safely exiting Upper Astley onto the A53 and also exiting Astley Lane onto the A49. A request was made that consideration is given to purchasing highway visibility mirrors to help the situation.

Mr Bill Rowland introduced himself as being a candidate standing for the Tern Division in the forthcoming elections following Councillor Picton's decision not to stand for re-election. After his brief introduction Mr Rowland left the meeting.

81.24 To approve the Minutes of the Parish Council Meeting held on 15 January 2025

The minutes of the previous meeting had been circulated.

It was proposed by Councillor Bedell and seconded by Councillor Mardell and

resolved (without opposition)

that the minutes of the Parish Council Meeting held on 15 January be accepted as a true record.

The minutes were signed accordingly.

82.24 Clerk's report on matters arising since the Parish Council Meeting on 15 January 2025

 Updated website with relevant information – Freedom Fibre's community engagement event at Hadnall Village Hall, Avian 'flu update, and advice on winter maintenance. This advice was given following a recent request for a salt bin from a parishioner. Shropshire Council had advised that no further salt bins will be provided in the county. A new page has been created on the website under Community Information giving full details about gritting and salting.

- Applied to Shropshire Council for a precept of £10,155 by the 31 January deadline.
- Advised internal auditor applicants of the outcome of the selection process.
- Received application packs for forthcoming elections on 1 May which were distributed at the meeting.
- Problems with new email client provided by HugoFox for .gov.uk email addresses: Spacemail has a very basic interface which lacks functionality. Clerk has many hundreds of emails dating back several years and there is no facility to sort or filter emails. This is not currently a workable situation and Spacemail have advised that they are making improvements imminently.
- Spoke to Planning Officers at Shropshire Council about incorrect assignment to Astley
 Parish of planning application 24/04834/FUL Construction of 45 dwellings, vehicular
 access via Shrewsbury Road, school car park, public open space, landscaping and planting,
 associated infrastructure and enabling works. Subsequently reassigned to Hadnall Parish.
- Prepared the Parish Council's entry for next edition of Hadnall & Astley News.
- Responded to parishioner's email requesting traffic safety mirrors at the Upper Astley
 junction with the A53. Since the initial response was sent, further research has been
 conducted. Shropshire Council is not currently accepting any applications for highway
 visibility mirrors and its relevant awarding policy states:

"The Policy takes account of the following factors:

- 1. The image that a driver sees in the mirror of an approaching vehicle appears to indicate that the vehicle is straight ahead, when it is in fact around a corner.
- 2. Reflective glare is a danger, particularly when reflected lights of passing vehicles tend to sweep across the vision of a driver waiting in a side road, or access, temporarily dazzling him/her.
- 3. The image in a mirror may be obscured or distorted by rain, snow, frost or condensation.
- 4. It is most difficult to judge the speed and distances of an approaching vehicle from the reflected image in a mirror.
- 5. Mirrors are affected by wear and tear and, in certain locations, may be prone to vandalism. Any minor misalignment of a mirror will result in serious distortion of the image. In some circumstances, misalignment may result in no image of an approaching vehicle whatsoever.
- 6. The erection of mirrors in the highway is not considered to be in the overall interests of road safety. Even when visibility is severely restricted, it is always considered preferable for a driver to rely on his/her own direct observations in negotiating hazards, rather than rely on possibly misleading artificial aids such as mirrors."

83.24 To receive reports from

a) Shropshire Councillor

Councillor Picton presented a brief update which covered:

 Budget – The budget for 2025/26 has now been set and further savings must be made as the Government settlement had not been what was expected and Shropshire Council ended up £28M worse off than in the previous year. The financial pressures being faced are due to the removal of the Rural Services Delivery Grant, which previously provided funding to offset the extra costs of delivering services in rural areas, and a reduction in social care funding.

- Local Plan Shropshire Council was given the choice by the inspectors to either withdraw the Local Plan or have it failed. It will therefore be withdrawn when Full Council next meets in July. Shropshire Council will go out with "a call for sites" (an opportunity for landowners, developers, and individuals to suggest areas for potential future development) but not until after the elections. Shropshire Council is vulnerable to speculative development, regardless of whether there is a Local Plan or not, as there is no 5-year land supply. Currently there is a 4.73-year land supply but hopefully with a couple of applications that have just come in, and two that have just been passed, it will increase to a 5-year land supply which would prevent the speculative development.
- Retirement Councillor Picton said that it had been an honour and privilege to serve the people of the Tern Division and that she had particularly enjoyed her time working with Astley Parish Council. But that after 42 years working in the Public Service is was time for her to step down and retire.

On behalf of Astley Parish Council, the Chairman thanked Councillor Picton for her years of dedicated service. All agreed that she had been a wonderful advocate for the parish, was a constant source of help and guidance, would be terribly missed and a hard act to follow. She wished her a long and happy retirement and this sentiment was echoed by the rest of the Parish Councillors. The Clerk expressed her personal thanks to Councillor Picton for all the help and support she had received which had greatly assisted in the carrying out of her duties.

[After the meeting a small celebration took place where Councillor Picton was presented with a thank you gift from the Parish Councillors personally.]

b) RAF Shawbury

Although Flight Sergeant Foxall was not able to attend the meeting, he had submitted his report in advance:

- Night Flying The next period commences on 31 March and is planned to 15 May. Night flying periods are usually for seven weeks with three weeks in between periods. There will be posts on the RAF Shawbury Facebook/X advising on the night flying periods and we are grateful for the tolerance of this essential training. There is also information on the RAF Shawbury webpage with contact details for complaints or concerns. Night flying will commence typically 30 minutes after sunset and may continue until 02:30.
- Helicopter Liaison Group The latest Helicopter Liaison Group Newsletter (No1 of 2025) has been issued and should be distributed to all Shropshire and Telford and Wrekin Town and Parish Councils. There are options for regional groups to be addressed by appropriate RAF Shawbury executives if warranted.
- **Upcoming Events** Landowners' and Rider Awareness Day will be held on 22 May. Invitations have gone out to the supporting Landowners and Horse Riders Groups.
- Airfield Works Programme The airfield's work programme is progressing well.
 These works will maintain the airfield operating surfaces for many more years to ensure our flying training continues. Where possible the main contractor is subcontracting local companies to bring benefit to the local area and lower the carbon footprint wherever possible

 airfields, civil and military, regarding the flying of drones and model aircraft.

Due to an initial coding issue with application 24/03985/FUL, the address had been incorrectly detailed as "Proposed Commercial Conversion Of Barn South East Of Astley Shrewsbury Shropshire". However, following the application validation, the Clerk contacted the relevant Planning Officer at Shropshire Council and queried the address. The address for application 24/03985/FUL was subsequently amended on the Planning Portal to read "The Firs Farm Astley Shrewsbury Shropshire". Unfortunately, application 25/00503/DIS is linked to the coding for application 24/03985/FUL and again the address detailed was "Proposed Commercial Conversion Of Barn South East Of Astley Shrewsbury Shropshire". Following the meeting the Planning Portal was amended and now shows the address correctly as "The Firs Farm Astley Shrewsbury Shropshire".

No further comments were recorded on the above planning applications.

86.24 To receive any relevant updates from parish councillors

- Councillor Bedell reported that the landowner (Mr C Jones) had done a great job in replacing smart new wooden railings on both sides of the bus shelter.
- The Parish Council wished to put on record its thanks to Mr Jones on behalf of the entire parish for carrying out this work.
- As the Parish Council/Village Hall Liaison, Councillor Sumner had attended the Village Hall Management Committee Meeting on 22 January and had submitted her report which follows.

The Village Hall Management Committee:

- o is pleased to have a Parish Council liaison providing a link/support from the Parish Council;
- o is looking to extend the car park, on to space where the shed was;
- o is working on fundraising events. Quiz nights are successful both as a means of fundraising; and bringing the community together. The next quiz night is on 11 April;
- held a ceilidh on 8 March. Despite there being concern before the event regarding ticket sales, it turned out to be supported and a small profit was made;
- o is planning a Spring fayre for 17 May;
- o is continuing to promote indoor games e.g. table tennis;
- o request the Parish Council checks the postcode on the defibrillator sited at the Village Hall.
